**ITEM 1.**

**To Appoint Mr. Mihir Doshi as an Independent Director of the Company:**

Mr. Mihir Doshi has been the Managing Director and Chief Executive Officer of India Operations of Credit Suisse Group since January 2006. He joined the Credit Suisse Group after spending 22 years at Morgan Stanley. He holds a BS (Honors) from NYU Stern and a CPA from New York State, which he gained while working with Deloitte Haskins and Sells, New York.

Mr. Mihir Doshi holds 30,000 Equity Shares of the Company.

In terms of Section 149 and other applicable provisions of the Companies Act, 2013, Mr. Mihir Doshi is proposed to be appointed as an Independent Director for 5 consecutive years up to 26<sup>th</sup> February, 2020. A notice has been received along with deposit of requisite amount from a member proposing Mr. Mihir Doshi as a candidate for the office of Director of the Company.
